### **Project Outline**

Cultural diversity is increasing in Maroondah, with an increase in the arrival of overseas immigrants.

Beyond the Barriers is a partnership with the Maroondah Learn Locals, with Yarrunga as the lead agent, who seek to formalise an alliance that will allow them to develop educational employment opportunities for CALD (Culturally and Linguistically Diverse) and Indigenous community organisations. The project will focus on identifying and developing initiatives and resources within the LLO's to effectively engage, encourage participation, and enhance existing pathways offered to the priority cohorts in the community through innovative, flexible and responsive approaches.

The project will work with Mullum Mullum Indigenous Gathering Place (MMIGP), Croydon Hills Baptist Church and Migrant Information Centre (MIC) to co design culturally appropriate learning pathways to Increase the accessibility of learning opportunities within Maroondah.

Beyond the Barriers has been funded by the Adult Community and Further Education (ACFE) Board as part of their Capacity and Innovation Fund (CAIF) – round 11.

The management of the project will be undertaken by Yarrunga Community Centre (including reporting and acquittal of funds to ACFE) with the shared participation in decision making by the Maroondah Learn Locals. The project will run between July 2019 and March 2020

### **Position Purpose**

- 1. Be responsible for liaising and working with the Lead Agent and the Manager consortium in scoping and reporting the projects milestones, Key activities and providing relevant receipts and documentation to support the final financial acquittal
- 2. To identify barriers currently preventing Indigenous and CALD people from accessing Learning pathways and develop strategies to address them
- 3. Support the strengthening of existing relationships with and seek to establish and consolidate new partnerships with the priority cohort community organisations.
- 4. Map and develop quality learning pathways and support the development of co designed materials and approaches to engage and provide a culturally appropriate learning environment.
- 5. Develop an engagement strategy to increase accessibility for the priority cohort.

## **Key Responsibilities**

- Use inclusive practices to identify barriers currently preventing Indigenous and CALD communities from accessing current learning pathways
- Develop strategies to address these barriers to participation
- Increase the engagement of priority cohorts within Maroondah
- Identify new stakeholders and potential partners to strengthen relationships with other training providers, government agencies, non-government agencies and industry to increase student access to further education, training and employment
- Create clear and defined pathway outcomes for learners through a network map, tracking tool (Online hub) and focus groups
- Develop a strategy to embed culturally appropriate practice in co design of programs and delivery of pre accredited training in Maroondah
- Assist with implementing programs in partnerships with other agencies that support the overall wellbeing of indigenous and CALD Students
- Improve the collaboration between participating Learn Locals
- Create an engagement strategy and evaluation tool to monitor participation in Maroondah
